Determination of Payments for Activities and Acts Implemented by Palacký University in Olomouc

I.

Introductory Provisions

Pursuant to Act No. 111/1998 Sb., on universities and on the amendment and modification of other acts (the Universities Act), as amended (hereinafter the "Act"),

I hereby decide

on the regulation and unification of payments for activities and acts implemented by Palacký University in Olomouc (hereinafter "UP"), which may be imposed on UP students and graduates under the Act.

II.

Determination of Payments

A. Payment of costs related to issuing duplicate copies of certificates

- a) a study credit book: CZK 250
- b) a university diploma: CZK 500
- c) a diploma supplement, or a certificate: CZK 500

B. Payment of costs related to matriculation and graduation ceremonies

The faculty may determine that the costs related to matriculation and graduation ceremonies be paid only if the faculty makes it possible for a student to receive the respective documents without the student or graduate respectively attending the ceremonies. This shall be decided by the Dean of the respective faculty.

- a) Payment of costs related to matriculation ceremonies: CZK 400.
- b) Payment of costs related to graduation ceremonies: CZK 500.

III.

Revenues from Payments

Revenues from payments under this Decision are revenues from the principal activity of the respective faculty, source No. 19.

IV.

Final Provisions

1. The present Decision repeals Decision of the Rector of UP No. B3-10/7-RR: Determination of Fees and Payments for Activities and Acts Implemented by Palacký University in Olomouc of 23 June 2010.
2. The present Decision comes into force once it has been signed by the Rector of UP,

and into effect on 1 September 2013.
